4. State Library Report

State Librarian Eli Guinnee presented the 4th Quarter FY25 Commission Report. USDA grant has been extended by a year, with three more sound booths being procured for public libraries and the new GetSetUp online learning platform getting much use; Federal funding for next FY is looking positive, in the budget for both the House and the Senate.
